Chris Millar Litus to Let

- Chris opened the meeting and introduced Lynn from Litus and our board members
- 60% of the proxies were turned in
- Minutes from 2018 meeting was approved
- There were 3 open positions and 3 homeowners' who ran for the board
- Homeowners who ran for a board position were Don Matheson, Susan Leinenweber and Stephanie Baron
- Stephanie is our new board member
- 2020 there will be 2 positions up for re-election
- If there were more homeowners running for the board than positions open, Litus to Let counts the votes and 2 homeowners are asked to assist in the counting in the back of the room

Four of a Kind Maintenance Company

- Owner Mike Chaffin of Four of a Kind was present and introduced the South Hampton's staff
- Our building manager is Michael Preston Chaffin and will be taking over the business in a few years
- Mike Chaffin presented a slide show of what their company has done to clean and update the South Hampton
- When the South Hampton has large projects that are not included in the daily maintenance, Four of a Kind supplies the labor at no extra cost to the homeowners, Homeowners pay for the materials
- Wall repair from the Embassy carts are addressed daily
- Ceiling lobby tiles has been replaced and tracts have been painted
- Stairways have been cleaned and painted
- Four of a Kind will keep the curbs outside the building free of debris
- Equipment rooms, equipment and common area rooms and doors have been painted

Hank Cigolle has managed Four of a Kind after Litus to Let was removed.
He has taken on the projects that Four of a Kind has completed and worked directly with them

Replacing Pipes for Heat & Air

• The pipe project will take place from October 2019 – April 2020. The cost is approximately \$250,000.00 taken from the November 2018 meeting notes

Exterior Building Project

- Don Matheson presented information on the project
- The project will take place from October 2019 to April 2020
- Homeowners will be informed which towers will be affected and when
- Homeowner's will need to remove all furniture from the balconies when their tower is worked on
- The project will include the exterior paint, railings and balcony floors.
- The project will be noisy and will depend on weather

Garage Ceiling Project

• Has been finished

Pool Area

- Hank Cigolle took on the new pool furniture project
- It was discussed at the meeting if we could leave our pool open for people to sit and read by for the off-season. Doug Millar said the KPMA pool between the North and South Hampton will remain open all year and there is new pool furniture on order
- The bathrooms, pool and pool surface has been renovated and the circular wall has been removed

Hot Water Tanks
